THE EUROPEAN INTERNATIONAL RULES FOR TRIALS.

1 Objective:

These rules are written for the European International held on 20 July 2022 till 24 July 2022 in the municipal of Opmeer in the Netherlands. These rules are based on the Rules of Trials from the ISDS version 2021.

2. OFFICIALS

2.1 THE TRIALS COMMITTEE

- a- The Trial Committee for this European International will be appointed by the Organization Stichting Hart Voor West-Friesland- to make decisions regarding the interpretation and/or administration of any rule in question, to lay out the course and generally supervise the running of this Trial.
- b At the European International Trial, the Trials Committee shall be 2 members of the Trial Committee as above mentioned and the 1 of the judges.

2.2 THE JUDGES

a. The Judges for the European International shall be selected by the Organization -Stichting Hart Voor West-Friesland.

3. ENTRIES

- a In order to compete in the European International, handlers whom were qualified for the CSC 2021 are invited. For the Netherlands the Organisation will complete a qualification trial.
- b Handlers qualified for the CSC 2021 are allowed to start another dog as used for qualification.
- c If a handler decided not to start the country can selected one of the reserve handlers.
- d Are all reserves starting and there are more handlers allowed to start, it is up to the country to select another handler.
- e Trial Entry Forms must be completed and lodged at the Organization Hart Voor West-Friesland secretary's office by the date specified on the National Entry Form. All requirements detailed on that form for the efficient running of the entry process must be followed.
- c No owner or substitute handler may handle more than two dogs in the European International.

4. NATIONAL QUALIFICATION FOR THE EUROPEAN INTERNATIONAL

- a All countries starting at the Continental Sheep Dog Society Championship are allowed to send in a team. For numbers see Appendix A.
- b Every country is allowed to enter 2 reserve dogs.
- c Every handler is allowed to enter an alternate dog.
- d the Organisation- Stichting Hart voor West-Friesland is allowed to invite handlers using a wild card.

5. EUROPEAN INTERNATIONAL QUALIFICATION RUNS

On Wednesday, 20 July 2022, Thursday 21 July 2022 and Friday 22 July 2022 the qualifying runs will be held. Best 15 combinations per day are allowed to start at the semi-finals.

Semi-finals at Saturday 23 July 2022. There will be 45 combinations start to run. Best 15 go's to the final on Sunday 24July 2022.

Finals on 24 July 2022.

6 SUPREME CHAMPIONSHIP

- a The Supreme Championship is restricted to the 15 highest pointed dogs in the Qualifying Trials.
- b Dogs will run in the order as determined by drawn on the field, on the evening before the Supreme Championship.

7. JUDGING PRINCIPLES

To be used in conjunction with the information entered in the ISDS Rules for Trials 2021.

8. UNFORESEEN CIRCUMSTANCES

If things are not describe and or unforeseen the Trail cie shall make a decision.

Every country is allowed to enter 2 reserve combinations.

Every handlers is allowed to start a maximum of 2 dogs.

Be aware the handlers qualified himself. He/she is allowed to start another dog as qualified.

Every handler can enter an alternate dog. Number of alternate dogs cannot be more as dogs starting by that handler.

A handler will never start 2 dogs on the same day during qualification rounds.

Cost will be:

Per starting combination: 70 euro

Alternate dog: 35 euro.
